Whereas, the Owner agrees to such rental, occupation, and use in consideration of certain payments and covenants herein enumerated;	
Now, therefore, the parties agree to the following terms and conditions:	
1. The Renter shall pay to the Owner the sum of \$\ no later than (the date at time the key to the hall is obtained).	nd

2. The Renter shall have access to and use of the venue from (time) on date) to (time) on (date), for the purpose of hosting the Renter's event.	
3. If snow removal is necessary, it will be done at additional expense to the Renter.	
4. There will be NO SMOKING or ALCOHOL in the building or on the property.	
5. No nails, tacks, tape or sticky stuff on the walls.	
6. Exit doors must be kept clear of obstacles at all times.	
7. Do not remove any township property from the hall.	
8. Before leaving, Renter shall notify Owner's Representative and leave the keys in the Drop Box at the hall after making sure:	
a) Doors and windows are locked b) Bathroom doors are left open c) Personal belongings and trash have been removed d) Floors are swept e) Tables & chairs are stacked neatly f) Thermostat set to 55° (in winter) g) Lights are off	

9. Upon Renter's completion of his/her obligations under (8 a-g) above and inspection by the Owner no later than the first business day following the rental period, the Owner shall return to Renter the security deposit minus any amounts deemed necessary to repair damages inflicted upon the venue by Renter and/or Renter's associates, guests, invitees, contractors, and all other persons whatsoever who enter the venue during the

rental period, whether or not such persons did so with Renter's knowledge or consent.



- 10. Renter will be liable for any physical damages, legal actions, and/or loss of reputation or business opportunities that Owner may incur as a consequence of the actions of Renter or any of Renter's guests while Renter is in control of the venue, and shall indemnify and hold harmless the Owner against any and all legal actions which may arise from Renter's use of the venue.
- 11. Any disputes arising under this contract shall be adjudicated in the Owner's local jurisdiction.
