## RESOLUTION OF THE TOWNSHIP BOARD OF WASHINGTON TOWNSHIP

WHEREAS even though said property lies entirely in Fulton Township, Washington Township has, since the establishment of the above referenced cemetery, maintained same with Township funds, and

WHEREAS the Township of Fulton has indicated a willingness to accept conveyance of said property, and to be responsible for continued maintenance of the cemetery contained thereon, and

WHEREAS the members of the Township Board of Township of Washington are of the opinion that it is in the best interest of the citizens of Washington Township, that this property, which lies entirely in Fulton Township, be conveyed to the Township of Fulton, where it will continued to be maintained, by the Township of Fulton, as a public cemetery,

## NOW THEREFORE BE IT RESOLVED THAT:

The Township of Washington shall convey the premises located in the Township of Fulton, Gratiot County, Michigan and described as:

Commencing 22 rods West of the Northeast corner, thence South 12 rods, West 11 rods, 2 ½ feet, Northeast to the center of the highway, East 7 rods to the point of beginning, Section 25, Township 9 North, Range 3 West, Fulton Township, Gratiot County, Michigan

to the Township of Fulton for the continued use as a public cemetery.
