Resolution to Adopt Road Improvement, Repair, and Maintenance Millage Increase Proposal

Resolution No. 2023-016

At a meeting of the Washington Township Board, Gratiot County, Michigan, held on July 20, 2023, at 7:00 p.m.

PRESENT: Howard Whaley, Barbara Hoffer, Kevin Whaley, Nancy Rogers, Eric Whitford ABSENT:

The following was moved by Nancy Rogers and seconded by Barbara Hoffer:

WHEREAS, townships may impose and levy *ad valorem* property taxes to finance lawful public improvements as authorized by the Michigan Constitution and other laws. Specifically, townships may provide funds to improve, repair, and maintain roads within the Township as authorized by Public Act 51 of 1951, MCL 247.651 *et seq.*, among other authorities; and

WHEREAS, townships may also provide for road improvements under special assessment statutes such as Public Act 188 of 1954, MCL 41.721 et seq. See MCL 41.722(1)(c) and (m); and

WHEREAS, the Township currently has an approved special assessment levy equivalent to 1.50 mills on properties to pay for road improvements and may discontinue such assessment; and

WHEREAS, the Township Board of Washington Township wishes to discontinue the special assessment and replace it with a new millage (if approved) of 1.50 mills for ten years, 2023 through 2032 inclusive, to improve, repair, and maintain roads within the Township as authorized under Michigan law.

NOW, THEREFORE, BE IT RESOLVED:

1. The Township Board of Washington Township, Gratiot County, Michigan, approves the following millage increase proposal language and directs the Clerk to submit it to be placed on the November 7, 2023 election ballot. See the language on the following page.

To, if approved, replace and discontinue an existing 1.50 mill special assessment for road improvements and fund improvements, repairs, and maintenance on roads within Washington Township, shall Washington Township adopt an increase of up to 1.50 mills (\$1.50 per \$1,000 of taxable value) in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution, subject to the required millage rollbacks, and collect it for ten years, 2023 through 2032 inclusive, raising an estimated \$42,972 in 2023?
