**RESOLUTION: ALTERNATE BOARD OF REVIEW DATES**

**WHEREAS,**

Section 53b of the General Property Tax Act, MCL 211.53b, requires a Board of Review that meets in July to meet on Tuesday following the third Monday in July, and a Board of Review that meets in December to meet on the Tuesday following the second Monday in December; and

**WHEREAS,**

Assessors who work for multiple townships are not always able to attend the Board of Review meeting for each township when they meet on the same day; and

**WHEREAS,**

MCL 211.30(2) allows a Township Board to authorize, by adoption of an ordinance or resolution, an alternative starting date in March when the Board of Review shall initially meet, which alternative starting dates shall be the Tuesday or Wednesday following the second Monday of March; and

**WHEREAS,**

Public Act 122 of 2008, effective May 9, 2008, allows an alternate July Board of Review meeting date during the week of third Monday in July, and an alternate December Board of Review meeting date during the week of the second Monday of December; and

**WHEREAS,**

It will benefit the residents and Washington Township to have the assessor available to assist the Board of Review and taxpayers in processing tax appeals and poverty exemptions;

**NOW, THEREFORE, BE IT RESOLVED;**

Washington Township agrees to allow for alternate dates to be scheduled by CSZ Assessing Services while contracted as assessor for Washington Township:

For the March Board of Review, second meeting in March which can be either Tuesday or Wednesday following the second Monday of March.

For the July Board of Review, an alternate date during the week of the third Monday in July.

For the December Board of Review, an alternate date during the week of the second Monday in December.
