RESOLUTION: Grave Digging Agreement

WHEREAS, Public Act 215 of 1937, MCL 128.1, *et seq.*, gives townships authority to establish, control, maintain and care for public cemeteries that are not owned by another municipality or private organizations; and

WHEREAS, Washington Township shall enter in agreement with a contracted service provider for grave digging services as needed; and

WHEREAS, a current Certificate of Liability Insurance is submitted to the township by the contracted service provider; and

WHEREAS, the Township Supervisor and Township Clerk are authorized to ratify and confirm the validity of such agreements annually.


